

# Public Opinion on a Foreign Government: Paraguayan Attitudes Towards the Chinese Government

## Introduction

- **Research question:** What affects Paraguayan attitudes towards the Chinese government?
- **Motivation:** Chinese investment in LAC region has increased. Paraguay is the only South American country to recognize Taiwan. Previous scholarship has not yet explored Paraguayan opinions on China

## Main Hypotheses

- **H1:** Support for democracy -> lower trust in the Chinese government
  - Scholars argue that individuals are more likely to approve of countries with similar governing styles
- **H2:** More economic concern (at the state and individual level) -> higher trust in China
  - Scholars argue that prioritizing the economy -> trust major powers

## Other Hypotheses

- **H3:** Higher attention to media leads to higher trust in the Chinese government
  - Scholarship shows that mass media in Paraguay has shunned China and supported Taiwan
- **H4:** Leaning right on ideology will lead to higher levels of trust in the Chinese government.
  - Scholars argue that right leaning parties in LAC -> lower trust in China

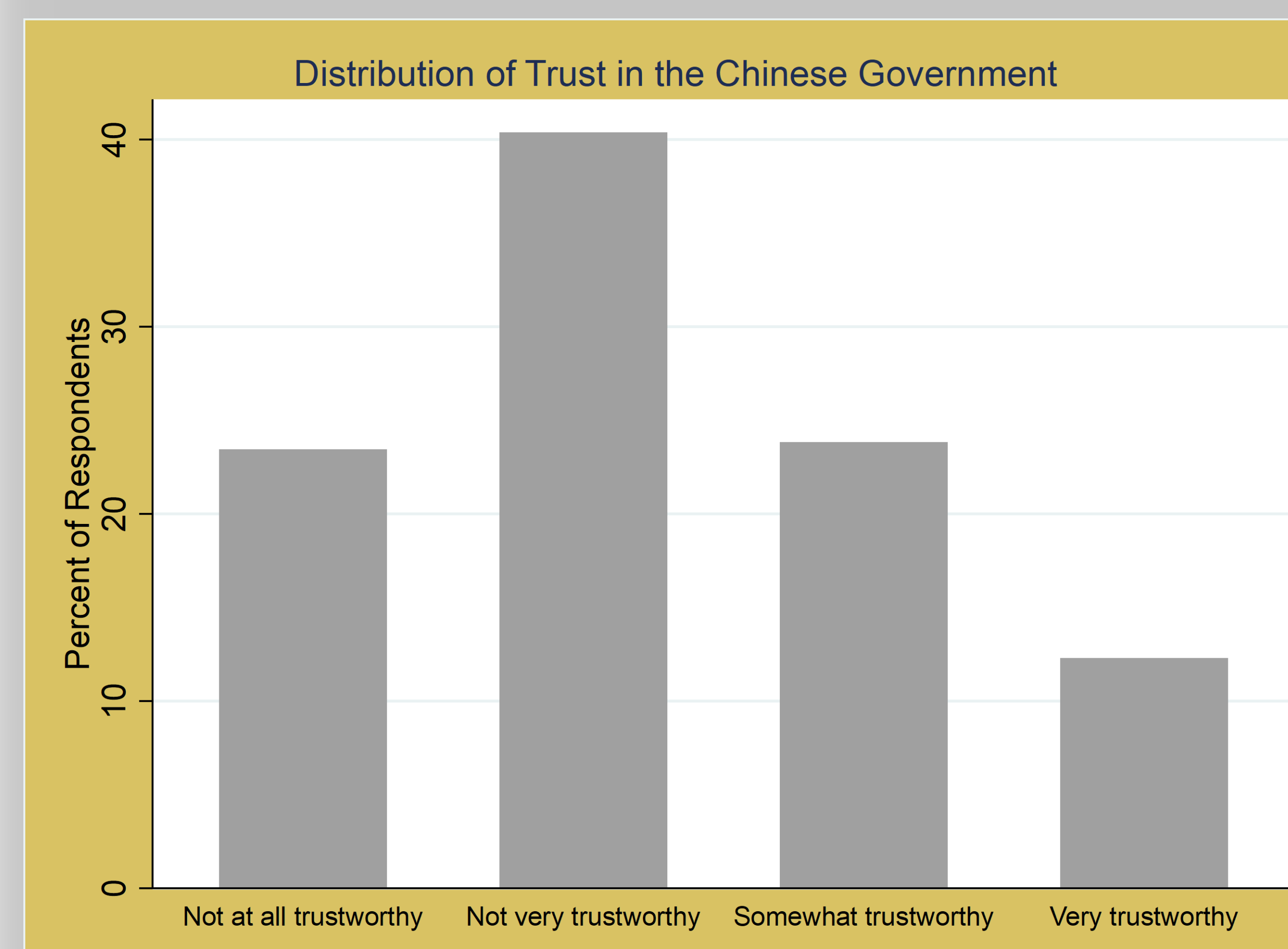

## Data

- 2023 AmericasBarometer national survey of Paraguay conducted by LAPOP Lab at Vanderbilt University

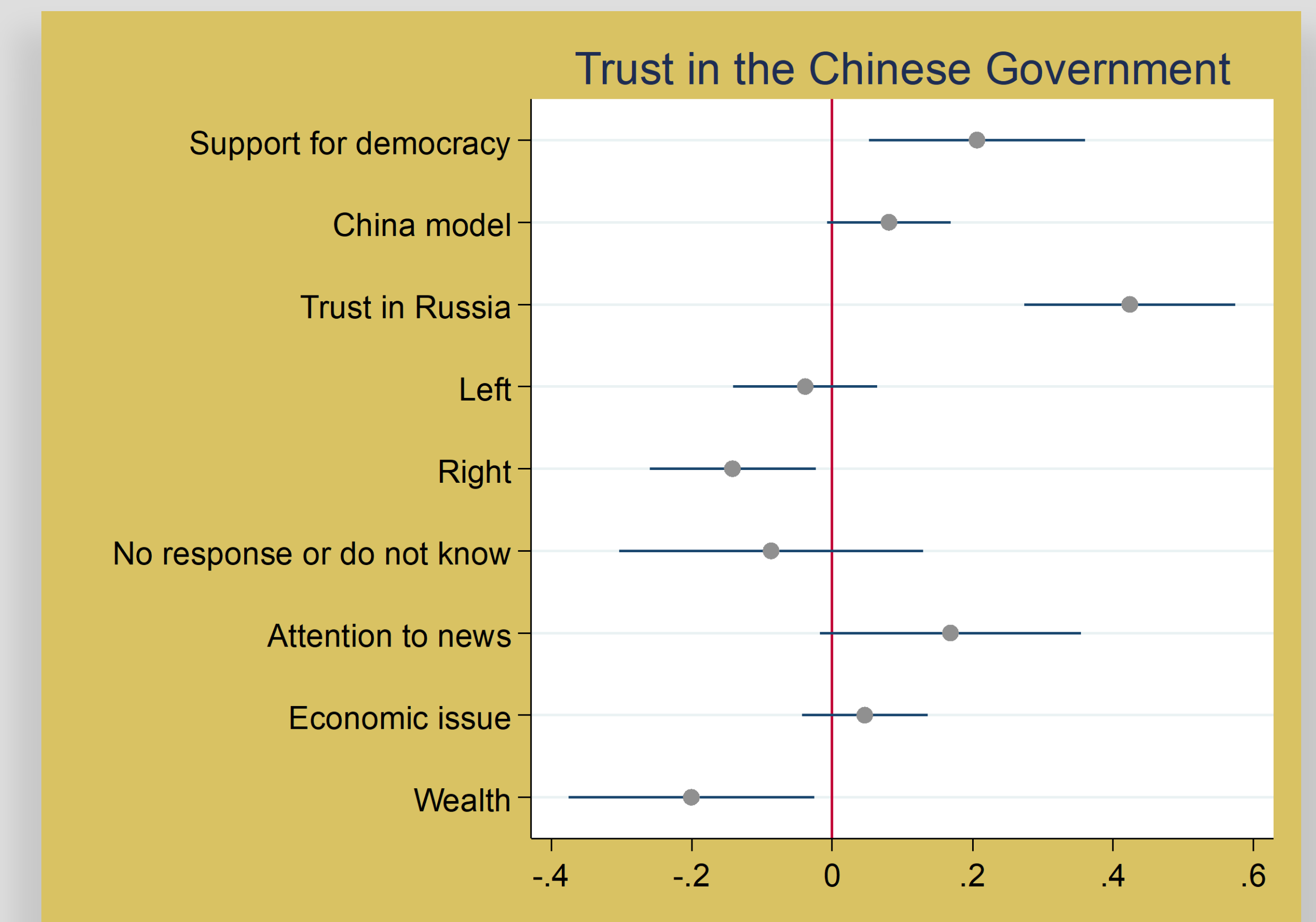
## Key Variables

- **Dependent variable:**
  - Trust in the Chinese government (1-4 scale, higher values = more trust)
- **Independent variables:**
  - *Support for democracy measures:* (1) Support for democracy scale (0-1); (2) U.S. model versus China model (0,1); (3) Trust in the Russian government (0-1)
  - *Economic factors:* MIP is economic (0,1); levels of wealth (0-1)
  - *Attention to media:* Frequency of news consumption (0-1)
  - *Ideology:* Left-right self-placement (0-1)



**Figure 1:** Distribution of Trust in China for Paraguayan's who have an opinion on the Chinese government

## Results/Discussion



**Figure 2:** OLS Regression model with control variables (p-value < 0.05)

- **H1:** Some consistency with the hypothesis, support for democracy is associated with higher trust in China but trust in Russia increases trust in China
- **H2:** Somewhat consistent with the hypothesis. More economically vulnerability predicts higher levels of trust, but having economic concern shows null results
- **H3:** No support for the hypothesis, attention to media shows null results
- **H4:** Supports the hypothesis, leaning right is associated with lower levels of trust

## Conclusion

- Public opinion is important to research because it could shape Latin America's role in U.S.-China tension
  - Future research should consider why support for democracy increases trust in China
  - Future research should look to understand high levels of non-response to questions on trust in China
